The para 3 (C) of the GO 1st read above, shall be read as:

(C) Road cutting Fees:

S.No	Type of Road	Charges
1	CC Roads	Rs.1,844/Rmt
2	BT Roads	Rs.2,275/Rmt
3	Foothpaths	Rs.799/Rmt
4	Berm/WBM	Rs.285/Rmt
5	Beyond Toe of embankment for Rural areas	Rs.156/Rmt
6	Beyond Toe of embankment for Urban areas	Rs.195/Rmt
7	Micro Trench Technology for depth of 600 mm, 50mm width and install 3 to 4 ducts of 40 mm dia	Rs.50/- Rmt
8	On Berm & Earthen Road formation for each pit of size (2mx1mx2m) (HDD)	Rs.595/- per pit (Within and beyond municipal limits)
9	On Bituminous/ Cement Concrete Road for each pit of size (2mx1mx2m) (HDD)	Rs.11,571/- per pit (Within GHMC and municipal limits) Rs.10,737/- per pit (Beyond municipal limits)

2. The above fees are exclusive of GST. The Centage charges @ 16.5% will be added extra on the amount of Road cutting charges. The GST @ 18% on Road cutting charges + Centage charges shall be paid by the applicant by way of Reverse charge mechanism. The applicant has to furnish the GST number while applying for road cutting permission online. Necessary amendment shall be made in the web portal for the above.
