**ORDER: -**

In the G.O.3<sup>rd</sup> read above, orders were issued for approving the reorganisation of the Greater Hyderabad Municipal Corporation into (12) Zones and (60) Circles.

**2.** Government, after careful examination/consideration of the administrative requirements arising out of the expansion of the city hereby decides to reorganise the existing Greater Hyderabad Municipal Corporation into (3) three separate Municipal Corporations.

**3.** Accordingly, the following notification shall be published in the Extraordinary issue of the Telangana Gazette, dated:11.02.2026.

**NOTIFICATION**

In exercise of the powers conferred under sub-section (1) of section 3 of the Greater Hyderabad Municipal Corporation Act, 1955 (Act II of 1956), as amended from time to time, the Government hereby declares and notifies the following Municipal Corporations:-

- (i) A Municipal Corporation shall be constituted and shall be called the Cyberabad Municipal Corporation, comprising the areas constituted by the Serilingampally, Kukatpally and Qutbullapur Zones, as reorganised in G.O.Ms.No.292, MA&UD (GHMC-1) Department, dated:24.12.2025.
  - (ii) A Municipal Corporation shall be constituted and shall be called the Malkajgiri Municipal Corporation, comprising the areas constituted by the Malkajgiri, Uppal and L.B. Nagar Zones, as reorganised in G.O.Ms.No.292, MA&UD (GHMC-1) Department, dated: 24.12.2025.
  - (iii) The remaining area comprising the areas constituted by the Shamshabad, Rajendernagar, Charminar, Golconda, Khairatabad and Secunderabad Zones, as reorganised in G.O.Ms.No.292, MA&UD (GHMC-1) Department, dated:24.12.2025 shall continue to be called the Greater Hyderabad Municipal Corporation.
  - (iv) Each Municipal Corporation so constituted under this order shall be a separate body corporate and shall sue and be sued in the said name and have perpetual succession and a common seal and subject to the provisions of the Greater Hyderabad Municipal Corporation Act, 1955, (Act No.II of 1956).
- 4.** This order shall come into force with immediate effect.
